- Thanks to ETEAM for 100 day celebration today

III. Minutes (**ACTION ITEM**) - August 21, 2023, *Kristen Kabel & Sara Parnass, Co-Recording Secretaries*

Motion made to approve Aug 21 minutes - Ellie Sweeney approved, Christina Stenman second that.

IV. Principal's Update - *Dr. Amy Besser, Principal*

- 100th Anniversary Celebration - 10/16 at 8am - Lots of special guests invited. Want to get invitation out soon to community. Looking to get a welcome banner or balloon arch.
- Volunteers - 26 approved volunteers as of now. Visitor policy - visitors must sign in at office, only can stay for 20 minutes (yellow badge) - approved volunteers must sign in too. This is from 7:40am - 6pm. Field trips might have a different policy. Visitors must have principal approval - why coming to visit? Can get approval the day of as long as teachers are aware.
- Academically - progress reports going home Friday (not for everyone. Only at risk of failing students). Teachers are finishing up assessments. Using the iReady program for diagnostic exams. Dibels is no longer being given in grades 3-5. K-2 still using Dibels.

V. Teacher Advisor Update - *Rachael Suarez, 5th Grade Teacher*

- District started the Cultural Arts Passport Program - we have the ability to submit a plan to get funding. For after school programs. Suggesting field trips for this but would get back at 5:03pm. May not be feasible for younger grades. Classes or workshops after school could work, or host family events or field trips on the weekend. Need to send a survey to school to see everyone's thoughts on this program.
 - Dr. Besser suggests adding in STEAM programs. Some field trip suggestions are an overnight camp trip. Every student must have access to this program so lower grade students will need other options. The Mission or Santa Barbara Zoo are other options.
 - Another option could be painted murals within school grounds.
 - This year has a lot more restrictions on how money can be spent. We seek vendors ourselves.
 - Volunteers still must be approved LAUSD volunteers
 - Survey will be sent out to ETeam first for thoughts. Don't want it to conflict with ETeam enrichment programs.

IV. Principal’s Update - Dr. Amy Besser, Principal

- Hurricane Hilary: minimal damage, branches down. Put a call in for tree trimming.
- Enrollment: Largest enrollment ever! 561 students!
- Opened 4th K classroom with Ms. Schmitt taking the role for now, hoping to hold for the entire school year. 6:00-06:30 she’ll present at the back to school on the 28th.
- TE class and TK will have 25 (27 is the max)
- Back to school night is Aug 29th, from 6-7, (2 Sessions)
- August 28th, specialists will begin, and PSW will be back on M, T, W, starting the same week. PSW will start FOCUS program in the 2nd and 4th grade
- Nick Melvoin came on the 16th
 - Questions:
 - TK still have aide? Yes, still a full time UTK assistant, and a 2nd assistant to support.
